 4 distribute punitive damages covers claimants scheduled to receive compensatory damage,
 5 and punitive damages principal and interest payments in the Unoiiled Fishery Claim
 6 Category (U00B) who have no impairments to their claims. *See* Declaration Of Lynn
 7 Lincoln Sarko In Support Of Lead Counsel's Fifteenth Punitive Damages Application For
 8 An Order Distributing Exxon Qualified Settlement Funds To Claimants In the Unoiiled
 9 Fishery Claim Category (U00B) And Their Attorneys, filed herewith.

12 Exhibits A through C to Mr. Sarko's declaration set out the amounts of
 13 compensatory damages, and punitive damages principal and interest going to claimants in
 14 the various categories. There are 17,184 claims being paid, the total amount of which is
