

1 1. I am the Court-appointed Claims Administrator of the Exxon Qualified
2 Settlement Fund (hereinafter "EQSF") and the Alyeska Qualified Settlement Fund
3 (hereinafter "AQSF"). I make this declaration based on personal knowledge and am
4 competent to testify to the matters set forth herein.
5

6 2. The current application to distribute punitive damages covers claimants
7 scheduled to receive punitive damages "interest and principal" payments in two
8 categories: (1) claimants in any of the 51 claim categories that have a single payment
9 which must be to a lienholder other than those who were covered in either the Ninth¹ or
10 Tenth² Applications; and (2) claimants who have resolved impairments on their claims
11 since the Tenth Application.

13 3. Exhibit A to this declaration sets out the amounts of punitive damages principal
14 going to claimants in both categories. There are 274 claims being paid, the total amount
15 of which is \$2,541,079.64. Exhibit B to this declaration sets out the amounts of punitive
16 damages interest going to claimants in both categories. There are 1060 claims being
17 paid, the total amount of which is \$22,006,080.21.

19 4. The dollar figures provided in Exhibits A and B are gross dollar allocations on
20 claims prior to any deductions for attorneys' fees or costs. The total amount of gross
21 payments under this Eleventh Distribution Application is approximately \$24,547,159.85.
