1 1. I am the Court-appointed Claims Administrator of the Exxon Qualified
2 Settlement Fund (hereinafter "EQSF") and the Alyeska Qualified Settlement Fund
3 (hereinafter "AQSF"). I make this declaration based on personal knowledge and am
4 competent to testify to the matters set forth herein.
5

6 2. In connection with proceedings related to the 16th Application for the
7 distribution of punitive damages, the Court in its November 10, 2010 order said:

8 At such time as Lead Counsel and the Administrator deem it appropriate
9 to finally terminate all administration of the EQSF, the Court would have
10 Lead Counsel and the Administrator consider the appropriateness and
11 feasibility of employing any remaining funds for the purpose of
12 ameliorating the shortages, which some claimants in various claims
13 categories (but in particular cannery workers) have suffered. [Clerk's
14 Docket No. 9658, p. 11].

15 In my declaration in support of the 22nd Application which was filed on August 31, 2011,
16 and in the accompanying application, Lead Counsel and I indicated preliminarily that we
17 anticipated seeking permission to implement the Court's request by asking to distribute a
18 portion of the 1% Contingency Fund to individual claimants who had, because of the
19 operation of the Plan of Allocation and the Plans of Distribution, received a substantially
20 smaller percentage of their damage award than individual claimants in other categories.

21 3. Though it will be a number of years until the administration of the EQSF will
22 be terminated, as there are proceeds due to many claimants that are unclaimed that I have
23 proposed be transmitted to various states for their unclaimed property programs, we are at

1 a point in claims administration whereby I can project that there are adequate resources to
 2 implement the Court's request. I have determined that from current reserves we would
 3 be able to distribute more than \$4.0 million to 2101 claimants to bring every *individual*
 4 claimant (including cannery workers)¹ to 90% of their estimated damages as calculated
 5 when we prepared the matrices that informed the Plan of Allocation and the Plans of
 6 Distribution. At the same time, I project that the remaining reserves will be sufficient to
 7 allow the EQSF to administer this distribution, to continue the work envisioned by the
 8 23rd and 24th applications, and to complete administration of the other distributions that
 9 are outstanding.
 10

11
 12 4. Other than the six claim categories, which are the subject of this application,
 13 every other claimant in the remaining 44 claim categories has received in excess of 90%
 14 of their target damage allocation under the Plan of Allocation and the Plans of
 15 Distribution. In contrast, because of the way the plans have worked, some claimants
 16 have received as little as 16.4% of their target allocation (a cannery worker), 41.1% for
 17 PWS shrimp trawlers, 45% for PWS sablefishers, 48% for processors, 81% for Cook
 18 Inlet miscellaneous shellfishers, and 87% for tenderers. The problems is obviously most
 19 exacerbated for cannery workers, but given that we have adequate resources to bring each
 20 individual claimant to 90% with the approximately \$4 million I propose to use for this
 21

 25 Processor, Tenderer and three other small fishery claim categories.

1 equalizing distribution, it seems appropriate to use the money to bring *every individual*
2 claimant to a uniform percentage of their target allocation.

3 5. Using the criterion that every individual claimant who has not yet received
4 90% of its damages as calculated under the plans of distribution would now receive 90%
5 of their target recovery, a total gross distribution of \$4,025,502.89 would be made,
6 broken out as follows:

- 8 • 1534 cannery worker claimants would receive a gross allocation of
9 \$1,431,356.49 as set out in pages 1-53 of Exhibit A;
- 10 • 45 M01H claimants (Cook Inlet Miscellaneous Shellfish) would receive
11 \$505.35 as set out in pages 54-55 of Exhibit A;
- 12 • 104 C06E claimants (Prince William Sound Sablefish) would receive
13 \$68,183.82 as set out in pages 56-59 of Exhibit A;
- 14 • 8 Prince P07E claimants (Prince William Sound Shrimp Trawl) would
15 receive \$49,243.26 as set out on page 60 of Exhibit A;
- 16 • 26 Fish Processor claimants would receive \$2,342,059.14 as set out on page
17 61 of Exhibit A; and
- 18 • 384 Tenderer claimants would receive \$134,154.83 as set out in pages 62-
19 75 of Exhibit A.

20 6. The dollar figures provided in Exhibit A are gross dollar allocations on claims

1 prior to any deductions for attorneys' fees. The total amount of gross payments under
2 this current application is approximately \$ 4,025,502.89.

3 7. If the Court approves the current request, I will begin authorizing payments to
4 be issued on behalf of, or to the listed claimants in the attached exhibits as soon as
5 possible.
6

7 8. In the Twenty-Fourth Application for the distribution of punitive damages,
8 which is being filed contemporaneously with the application supported by this
9 declaration, Lead Counsel and I have asked for permission to distribute any unclaimed
10 funds to state unclaimed property funds, if after specific efforts to find claimants are
11 undertaken, they have still not come forward to claim their awards. We ask that the same
12 procedures be used in connection with those claimants identified to receive a distribution
13 through this application that were used for those listed in the Twenty-Fourth application
14 if we are not able to distribute their recoveries.

17 9. I anticipate that after this distribution has been made and all other outstanding
18 approved claim payments have been made to claimants, lienholders, or the various states'
19 unclaimed property funds, and all administrative expenses paid, there may remain a small
20 portion of our contingency funds. A final application would include our recommendation
21 for distribution of any such funds.


